1. Introduction: what a publication scheme is and why it has been developed

One of the aims of the Freedom of Information Act 2000 (which is referred to as FOIA in the rest of this document) is that public authorities, including all maintained schools, should be clear and proactive about the information they will make public.

To do this we must produce a publication scheme, setting out:

- The classes of information which we publish or intend to publish;
- The manner in which the information will be published; and
- Whether the information is available free of charge or on payment.

The scheme covers information already published and information which is to be published in the future. All information in our publication scheme is available in paper form.

Some information which we hold may not be made public, for example personal information.

This publication scheme conforms to the model scheme for schools approved by the Information Commissioner.

2. Aims and Objectives

The school aims are:

- To ensure that the curriculum provides a Catholic/Christian setting in which each individual can fulfil his/her potential, growing in understanding and in the acquisition of skills, attitudes and values

- To make prayer, worship and liturgy real educational experiences and to contribute successfully to the development of the faith of each individual in the school community
- To ensure that the pupils' experience within the school has a formative and significant influence on their understanding and relationships, preparing them for a multi-cultural society.
- To create a dynamic interaction between home, parents and school which provides preparation for the pupils entry into the wider community
- To show concern, in a school which looks to Christ for the basis of its existence, for all the pupils, teaching and non-teaching staff and parents.

and this publication scheme is a means of showing how we are pursuing these aims.

3. Categories of information published

The publication scheme guides you to information which we currently publish (or have recently published) or which we will publish in the future. This is split into categories of information known as 'classes'. These are contained in section 6 of this scheme.

The classes of information that we undertake to make available are organised into four broad topic areas:
